**In the One Hundred and Eighty-Ninth General Court  
(2015-2016)**

An Act relative to the creative economy.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Subsection (a) of section 148B of chapter 149 of the Massachusetts General  
2 Laws is hereby amended by inserting the following clause:-

3 (4) or if an individual who is engaged in a profession, trade, or occupation that creates  
4 intellectual property that is or is not protected under federal copyright law, federal patent law,  
5 federal licensing laws or any other applicable federal, state or international law or treaty  
6 governing intellectual property is exempt from section 148B of chapter 149 if they meet the  
7 following:

8 (i) The individual identifies, markets, or promotes themselves as a freelancer, as self-  
9 employed, as a sole proprietor or as an independent business.

10 (ii) The individual controls and regularly negotiates the use of their intellectual property.

11 (iii) The individual meets the federal standards on independent contractors such, as but  
12 not limited to, the Internal Revenue Service 20 Factor Test and any Internal Revenue Service or  
13 federal industry specific independent contractor test that may exist.

14 The exception shall not apply to an individual who has been coerced, threatened or  
15 intimidated into establishing an independent business.

16 SECTION 2. Notwithstanding any general or special law to the contrary, if an individual  
17 is a member or is affiliated with a union, guild, membership organization, or professional  
18 organization, the employer of the individual is required to abide by the work standards, contracts,  
19 pay rate and/or other work practices and agreements established by said union, membership  
20 organization, professional organization, or guild. Membership in a professional development  
21 organization, union, guild created by a specific employer for its employees and/or independent  
22 contractors shall not meet the definition of a union, guild, membership organization or  
23 professional organization.
