**In the One Hundred and Eighty-Ninth General Court
(2015-2016)**

An Act providing opportunity for youth with substance abuse needs.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. To provide for improvements to substance abuse recovery services in the
2 commonwealth in fiscal year 2015, the sums set forth in section XY are hereby appropriated
3 from the General Fund for the several purposes and subject to the conditions specified in this act
4 and subject to laws regulating the disbursement of public funds; provided, however, that
5 notwithstanding any general or special law to the contrary, appropriations made herein shall not
6 revert and shall be available for expenditure until June 30, 2016.

7 SECTION 2. 7035-XXXX For reimbursements to cities, towns, and regional school
8 districts for the cost of transportation of resident pupils as required by subsection (f) of section
9 91 of chapter 71 of the General Laws; provided, that the commonwealth’s obligation shall not
10 exceed the amount appropriated in this item \$1,200,000

11 SECTION 3. Section 91 of Chapter 71 of the General Laws is hereby amended by adding
12 the following new subsection:-

13 (f) A municipality wherein a student resides who is admitted to a Recovery High School ,
14 shall, when necessary, provide for the transportation of such student, and shall, subject to
15 appropriation, be entitled to state reimbursement to the full extent of the amount expended. Such
16 municipality shall not be required to pay, but is not barred from paying, for any eligible student
17 to be transported in a manner that requires the student to remain in the vehicle for more than one
18 hour each way.
