## The Commonwealth of Alassachusetts

In the One Hundred and Eighty-Ninth General Court (2015-2016)

An Act creating a maximum allowable check-cashing rate.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Chapter 169A of the General Laws is hereby amended by adding after
- 2 section 13 the following section:

4 Section 14. (a) Notwithstanding any other provision of the law to the contrary, no check-

- casher licensed or subject to regulation under this chapter shall directly or indirectly charge or
- 6 collect fees or other considerations for rendering currency exchange services in excess of the
- 7 following:

- 8 (1) 1.5 per cent of the face value of the check plus a service charge of one dollar for any
- 9 government check issued by the United States, the Commonwealth of Massachusetts or any
- 10 political subdivision thereof.

- 11 (2) 3 per cent of the face value of a payroll check 100 dollars or less plus a service 12 charge of one dollar; 2.25 per cent of the face value of a payroll check greater than 100 dollars 13 plus a service charge of one dollar.
- (3) 5 per cent of the face value of the check or 5 dollars, whichever is greater, plus a
  service charge of one dollar, for all personal checks.
- (4) 3 per cent plus a service charge of 1 dollar for all other payment instruments,
  including checks, drafts, or money orders.

(b) No check-casher licensed or subject to regulation under this chapter shall charge more
 than 5 dollars to set up an initial customer account.

21 SECTION 2. Section 13 of said chapter 169A is hereby amended by striking out, in line 22 2, the words "five hundred" and inserting in place thereof the following words: - one thousand.
