**In the One Hundred and Eighty-Ninth General Court  
(2015-2016)**

An Act requiring microphones and audio-recorders on tasers.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Chapter 140 of the General Laws is hereby amended by inserting after  
2 section 131J the following section:-

3           131J1/2. In a municipality that accepts this section, any portable device or weapon  
4 described in section 131J that is possessed by a municipal law enforcement officer for the  
5 purpose of his or her official duties shall be capable of recording and amplifying sound;  
6 provided, however, that an officer may possess a portable device or weapon that is incapable of  
7 recording and amplifying sound if the portable device or weapon was purchased by the  
8 municipality before this section is accepted.

9           SECTION 2. Subsection D of section 99 of chapter 272 of the General Laws is hereby  
10 amended by inserting, after paragraph 1 (f), the following paragraph:

11           (g) for a law enforcement officer, acting in the performance of his or her official duties,  
12 while clearly identified as a law enforcement officer to violate the provisions of this section.  
13 Notwithstanding this provision, law enforcement officers may not record inside a person's  
14 residence without the consent of a resident.
