By Mr. Smola of Warren, a petition (accompanied by bill, House, No. 2177) of Todd M. Smola, Shaunna L. O’Connell and Kevin J. Kuros that the Executive Office of Public Safety be directed to create a blue alert system, so-called, for the apprehension of individuals wanted for seriously injuring or killing law enforcement officials. **In the One Hundred and Eighty-Ninth General Court
(2015-2016)**

An Act relative to implementing a blue alert system in the Commonwealth.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 18³/₄ of chapter 6A of the General Laws, as appearing in the 2008
2 Official Edition, is hereby amended by adding the following clause:-

4 (10) to develop and implement a statewide blue alert system to be activated when law
5 enforcement officials are searching for an individual who is wanted in the serious injury or
6 killing of a police officer, state trooper, or other law enforcement official.

8 SECTION 2. Chapter 6A of the General Laws, as appearing in the 2008 Official Edition,
9 is hereby amended by inserting after section 19A the following section:-

11 Section 19B. The executive office of public safety shall coordinate the implementation of
12 a statewide blue alert system, pursuant to section 21 of chapter 22.

14 SECTION 3. Chapter 22 of The General Laws are hereby amended by adding the
15 following section:-

19 THE STATEWIDE BLUE ALERT SYSTEM

21 Section 1. The following terms as used in this chapter shall, unless the context clearly
22 appears otherwise, have the following meanings:

23 “Executive office”, the executive office of public safety.

24 "Law enforcement agency", a law enforcement agency with jurisdiction over the
25 investigation of a crime resulting in the serious injury or death of a police officer, state trooper,
26 or other law enforcement official.
