The Commonwealth of Alassachusetts

In the One Hundred and Eighty-Ninth General Court (2015-2016)

An Act relative to increasing the COLA base.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Paragraph (c) of section 102 of said chapter 32, as so appearing in the 2012
- 2 Official Edition, is amended by striking out in lines 32, 36 and 43 the dollar amount \$13,000 and
- 3 inserting in place thereof the following dollar amount: \$16,000.
- 4 SECTION 2. The provisions of sections one of this act shall take effect for cost of living
- 5 adjustments to be made, in accordance with the provisions of section 102 of said chapter 32,
- 6 commencing July 1, 2015.
