**In the One Hundred and Eighty-Ninth General Court
(2015-2016)**

An Act to amend retirement benefits for certain employees of the Department of Correction.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Section 3 of chapter 32 of the General Laws, as appearing in the 2012
- 2 Official Edition, is hereby amended by inserting after the words "assistant deputy
- 3 superintendent", in line 304, the following words:- "correctional program officer I, II, III;"
