An Act An act reducing filing fees for certain small business.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 12 of chapter 156C, as so appearing, is hereby amended by striking subsection  
2 (d) of paragraph (9) and inserting in place thereof the following:

3 The fee for the filing of the certificate of organization required by subsection (a) shall be  
4 five hundred dollars. The fee for the filing of the annual report required by subsection (c) shall be  
5 two hundred and fifty dollars for any such limited liability company with five or fewer  
6 employees; or five hundred dollars for any such limited liability company with greater than five  
7 employees. Such fees shall be paid to the state secretary at the time the certificate of organization  
8 or the annual report is filed.
