Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Section 18 of Chapter 30A of the General Laws, as appearing in the 2012
- 2 Official Edition, is hereby amended by inserting after the word meeting in line 8, the following

- 6 (e) A session of a town meeting convened under section 10 of chapter 39 which may

- 8 quorum of a public body at any such session.
