An Act officially making the month of March multiple system atrophy awareness month.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Chapter 6 of the General Laws, as appearing in the 2012 Official Edition, is  
2 hereby further amended by adding, after section 15TTTTT, the following:-

3           Section 15QQQQQ. The governor shall annually issue a proclamation setting apart the  
4 month of March as Multiple System Atrophy Awareness Month, to increase awareness and  
5 understanding of the contributions made by persons suffering from MSA, which is a rare  
6 neurological condition with an unknown cause, and recommending that said month be observed  
7 in an appropriate manner by the people.
