An Act designating the Commonwealth of Massachusetts as a Purple Heart State.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           WHEREAS, the people of the The Commonwealth of Massachusetts have great  
2           admiration and the utmost gratitude for all the men and women who have selflessly served their  
3           country and this community in the Armed Forces for the good of all; and

4           WHEREAS, contributions and sacrifices of the men and women from Massachusetts who  
5           served in harm’s way in the Armed Forces have been vital in maintaining the freedom and the  
6           way of life enjoyed by our citizens; and

7           WHEREAS, citizens of our Commonwealth of Massachusetts have been killed in action  
8           while serving in the Armed Forces and have been posthumously awarded the Purple Heart for  
9           their ultimate sacrifice; and

10           WHEREAS, citizens of our Commonwealth of Massachusetts have been awarded the  
11           Purple Heart for their bodily sacrifice of being wounded in action while engaged in combat; and

12           WHEREAS, the Purple Heart is the oldest American military decoration in present use  
13 and was created as The Badge of Military Merit, made of purple cloth, shaped as a heart with the  
14 word “Merit” sewn upon it, on August 7, 1782 in Newburgh, New York by General George  
15 Washington.

16           WHEREAS, the heritage it represents is sacred to those who know the price paid to wear  
17 the Purple Heart; and

18           WHEREAS, August 7th is nationally recognized as Purple Heart Appreciation Day; and

19           NOW, THEREFORE BE IT PROCLAIMED, We the State Legislature of Massachusetts  
20 (I The Governor of the Commonwealth of Massachusetts) on behalf of the grateful citizens of  
21 Massachusetts , take pleasure in proclaiming Massachusetts a Purple Heart State, honoring the  
22 service and sacrifice of our nation’s men and women in uniform that were wounded or killed by  
23 the enemy while serving to protect the freedoms enjoyed by all Americans.

24           ALSO, BE IT PROCLAIMED, We the Commonwealth of Massachusetts will recognize  
25 August 7th annually as Purple Heart Day, and urge the people and organizations of Huntington  
26 to display the American Flag as well as other public expressions of recognition of our Purple  
27 Heart recipients.
