An Act to further recycling across the Commonwealth.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 323 of Chapter 94 of the General Laws as appearing in the 2010  
2   Official Edition is hereby amended inserting after the word s “at the location at which the dealer  
3   obtains” the following:-

4           “any”

5           SECTION 2. Section 323 of Chapter 94 of the General Laws as appearing in the 2010  
6   Official Edition is hereby amended by inserting at the end the following paragraph:-

7           (j) “The distributor must authorize for acceptance from any and all dealers utilizing  
8   reverse vending machines for deposit redemption all containers sold exclusively by said  
9   distributor to any dealer in the past sixty days. The distributor must also authorize for

10 acceptance from a dealer utilizing reverse vending machines for deposit redemption any  
11 container sold specifically to that dealer. Bottlers of any multi-store dealer's private label or  
12 exclusive brand container or the dealer itself must authorize for acceptance from any and all  
13 dealers utilizing reverse vending machines for deposit redemption all containers sold by said  
14 multi-store dealer in the past sixty days."
