**In the One Hundred and Eighty-Ninth General Court  
(2015-2016)**

An Act relative to net metering.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Subsection (f) of section 139 of chapter 164 of the General Laws, as  
2 appearing in the 2012 Official Edition, is hereby amended by striking out, in line 68, the figure  
3 “4”, as inserted by section 5 of chapter 251 of the acts of 2014, and inserting in place thereof the  
4 following figure:- 5.

5 SECTION 2. Said subsection (f) of section 139 of chapter 164, as so appearing, is hereby  
6 further amended by striking out, in line 70, the figure “5”, as inserted by section 6 of chapter 251  
7 of the acts of 2014, and inserting in place thereof the following figure:- 7.

8 SECTION 3. Subsection (c) of section 7 of chapter 251 of the acts of 2014, as so  
9 appearing, is hereby amended by striking out, in line 4, the date “March 31, 2015” and inserting  
10 in place thereof the following: "June 1, 2015".
