**In the One Hundred and Eighty-Ninth General Court
(2015-2016)**

An Act relative to mental health, suicide prevention and transition services for veterans.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Chapter 115 of the General Laws, as appearing in the 2012 Official Edition, is hereby
2 amended by adding the following section:-

3 Section 16. Section 1. The department of veterans affairs and the department of mental
4 health in coordination with an advisory committee established in section 2 shall convene an
5 advisory committee to investigate and study ways to augment services to returning veterans to
6 reduce the rate of suicide and the effects of post traumatic stress disorder, depression and anxiety
7 among veterans. The committee shall investigate and study the complexity of reintegration into
8 civilian life and issues related to isolation and suicide among veterans.

9 The committee shall also examine the following topics: the relationship between having a
10 community peer liaison and reintegration into society among these diagnosed veterans; the
11 relationship between isolation and suicide among veterans; the relationship between having a

12 community peer liaison and changes in symptoms of post traumatic stress disorder, depression or
13 anxiety in diagnosed veterans.

14 The committee shall report to the general court the results of its investigation and study
15 and any recommendations by filing the same with the clerks of the house of representatives and
16 the senate who shall forward the same to the chairs of the joint committee on veterans affairs and
17 the joint committee on mental health and substance abuse on or before January 1, 2016.

18 Section 2. The department of veterans affairs shall convene an advisory committee
19 consisting of 12 members; 2 of whom shall be members of Massachusetts chapter of Team Red,
20 White and Blue; 2 of whom shall be members of Red Sox Foundation and Massachusetts
21 General Hospital Home Base Program; 2 of whom shall be members of Wounded Warriors
22 Project; 2 of whom shall be members of Mass Mentoring Partnership; 2 of whom shall be
23 members of the Massachusetts Coalition for Suicide Prevention and 2 of whom shall be members
24 of the Massachusetts Psychological Association. The committee shall provide support and
25 expertise to reduce isolation and suicide among returning veterans. The members of the
26 committee shall have experience in mental health or veterans support services with an emphasis
27 on treatment of post traumatic stress disorder, depression and anxiety among veterans.
