**In the One Hundred and Eighty-Ninth General Court
(2015-2016)**

An Act relative to veterans preference for public housing.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Notwithstanding any general or special law to the contrary the Department
2 of Housing and Community Development shall not promulgate any rules or preference
3 categories for public housing without giving preference to a veteran from another community
4 over a local resident.

5 SECTION 2. The Department of Housing and Community Development shall
6 promulgate regulations in accordance with SECTION 1.
