**In the One Hundred and Eighty-Ninth General Court
(2015-2016)**

An Act relative to shelter benefits for veterans.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Chapter 115, Section 5 of the Massachusetts General Laws, as appearing in
- 2 the 2012 Official edition is hereby amended by striking out the following words in line 1:-
- 3 “,subject to appropriation,”
