In the One Hundred and Eighty-Ninth General Court  
(2015-2016)

An Act relative to public information requests.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 55 of chapter 51 of the General Laws, as appearing in the 2012  
2 Official Edition, is hereby amended by adding the following paragraph:-

3 Registrars shall provide to the state secretary a copy of each such voting list required by  
4 this section; provided, however that the registration of a voter in the commonwealth’s electronic  
5 registration system shall be sufficient to provide the state secretary with the voting list. Any  
6 such list shall be a public record in the custody of the state secretary and the state secretary shall  
7 respond to any request for regional or statewide voting lists. The request for inspection or copy  
8 of such public record shall be governed by chapter 66.

9 SECTION 2. Section 91 of chapter 54 of the General Laws, as so appearing, is hereby  
10 amended by adding the following paragraph:-

11 Registrars shall provide to the state secretary a copy of each absentee voting list required  
12 by this section. Any such list shall be a public record in the custody of the state secretary and the

13 state secretary shall respond to any request for regional or statewide absentee voting lists. The  
14 request for inspection or copy of such public record shall be governed by chapter 66.

15 SECTION 3. Section 91A of said chapter 54, as so appearing is hereby amended by  
16 adding the following paragraph:-

17 Registrars shall provide to the state secretary a copy of each specially qualified voter list  
18 required by this section. Any such list shall be a public record in the custody of the state  
19 secretary and the state secretary shall respond to any request for regional or statewide specially  
20 qualified voter lists. The request for inspection or copy of such public record shall be governed  
21 by chapter 66.
