WHEREAS, IT IS THE SOLEMN DUTY OF THE STATES TO PROTECT THE
LIBERTY OF OUR PEOPLE, PARTICULARLY FOR THE GENERATIONS TO COME, BY

PROPOSING AMENDMENTS TO THE CONSTITUTION OF THE UNITED STATES
THROUGH A CONVENTION OF THE STATES UNDER ARTICLE V OF THE UNITED
STATES CONSTITUTION TO PLACE CLEAR RESTRAINTS ON THESE AND RELATED
MISUSES OF POWER.

17 RESOLVED, THE GENERAL COURT OF THE COMMONWEALTH OF
18 MASSACHUSETTS HEREBY APPLIES TO CONGRESS UNDER THE PROVISIONS OF
19 ARTICLE V OF THE CONSTITUTION OF THE UNITED STATES, FOR THE CALLING OF
20 A CONVENTION OF THE STATES TO PROPOSE AMENDMENTS TO THE UNITED
21 STATES CONSTITUTION REQUIRING THAT IN THE ABSENCE OF A NATIONAL

EMERGENCY THE TOTAL OF ALL FEDERAL OUTLAYS MADE BY THE
CONGRESS FOR ANY FISCAL YEAR MAY NOT EXCEED THE TOTAL OF ALL
ESTIMATED FEDERAL REVENUES FOR THAT FISCAL YEAR, TOGETHER WITH ANY
RELATED AND APPROPRIATE FISCAL RESTRAINTS.

RESOLVED, THIS APPLICATION IS TO BE CONSIDERED AS COVERING THE
SAME SUBJECT MATTER AS THE PRESENTLY OUTSTANDING BALANCED BUDGET
APPLICATIONS FROM OTHER STATES AND SHALL BE AGGREGATED WITH THE
PRESENTLY OUTSTANDING BALANCED BUDGET APPLICATIONS OF OTHER
STATES FOR THE PURPOSE OF ATTAINING THE TWO-THIRDS OF STATES
NECESSARY TO REQUIRE THE CALLING OF AN ARTICLE V CONVENTION FOR
PROPOSING A BALANCED BUDGET AMENDMENT
