**In the One Hundred and Eighty-Ninth General Court  
(2015-2016)**

An Act establishing an Eastern Regional Commission on the status of Women and girls.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           (a) There shall be an Eastern Regional commission on the status of women which shall  
2 consist of 9 persons to be appointed by the commission on the status of women established in  
3 section 66 of chapter 3 of the General Laws. The Eastern Regional commission shall conduct an  
4 ongoing study of all matters concerning women in Eastern Regional communities. The Eastern  
5 Regional commission shall report its findings to the commission on the status of women  
6 annually, not later than June 2, and shall recommend solutions to the problems facing women in  
7 Eastern Regional communities. The commission on the status of women shall make  
8 appointments to the Eastern Regional commission from a pool of applicants who reside in  
9 Eastern Regional communities. For the purpose of this act, "Eastern Regional communities"  
10 shall mean municipalities located within Norfolk and Suffolk county.

11           (b) Members shall serve for 3-year terms and shall continue in office until their  
12 successors are appointed. Members shall not be reappointed for more than 2 consecutive terms;

13 provided, however, that former members may reapply to serve on the commission after 1 year  
14 has passed since their last term. Of the initial members appointed to the Eastern Regional  
15 commission on the status of women, 3 members shall be appointed for a term of 1 year, 3  
16 members shall be appointed for a term of 2 years and 3 members shall be appointed for a term of  
17 3 years.

18 (c) Vacancies in the membership of the Eastern Regional commission on the status of  
19 women shall be filled by the commission on the status of women for the balance of the unexpired  
20 term.

21 (d) In making appointments to the Eastern Regional commission on the status of women,  
22 the commission on the status of women shall consult with women's organizations. Nominations  
23 shall be solicited between August 1 and September 16 annually through an open application that  
24 is widely distributed throughout the Eastern Regional communities. Members of the commission  
25 shall be diverse and represent different Eastern Regional communities.

26 (e) Members shall serve on the Eastern Regional commission on the status of women as  
27 volunteers and shall not be compensated.

28 (f) The Eastern Regional commission on the status of women shall elect from among its  
29 members a chair, a vice chair, a treasurer and any other officers as it deems necessary.

30 (g) The Eastern Regional commission on the status of women shall meet at least 4 times  
31 a year, at the members' discretion. Members of the commission on the status of women may  
32 attend the meetings of the Eastern Regional commission on the status of women.

33           (h) The Eastern Regional commission on the status of women may accept and solicit  
34 funds, including any gifts, donations, grants or bequests and federal funds for any of the purposes  
35 of this act. The funds shall be deposited in a separate account to be expended at the discretion of  
36 the commission.

37           (i) The Eastern Regional commission on the status of women may: (i) use voluntary and  
38 uncompensated services of private individuals, agencies and organizations as may, from time to  
39 time, be offered or required; (ii) recommend policies and make recommendations to state and  
40 local agencies and officers to effectuate the purposes of the commission; (iii) enact by-laws for  
41 its own governance; (iv) hold regular public meetings, conduct fact-finding hearings and hold  
42 other public forums as it deems necessary; and (v) take other actions as it deems necessary to  
43 effectuate its purposes.
