**In the One Hundred and Eighty-Ninth General Court

An Act requiring medical exams for certain school bus drivers.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 8A of chapter 90 of the General Laws, as appearing in the 2012 Official Edition,
2 is hereby amended by striking out, in lines 11 and 12, the words “licensed physician within a
3 three” and inserting in place thereof the following words:- medical professional listed on the
4 federal Motor Carrier Safety Administration’s National Registry of Certified Medical Examiners
5 within a 6.
