By Messrs. Hecht of Watertown and Lawn of Watertown, a petition (accompanied by bill, House, No. 3614) of Jonathan Hecht, John J. Lawn, Jr. and William N. Brownsberger (with the approval of the town council) that the town of Watertown be authorized to issue fifteen additional licenses for the sale of alcoholic beverages. Consumer Protection and Professional Licensure. [Local Approval Received.]

**The Commonwealth of Massachusetts**

**In the One Hundred and Eighty-Ninth General Court  
(2015-2016)**

An Act authorizing the town of Watertown to grant 15 additional licenses for the sale of all alcoholic beverages to be drunk on the premises.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. (a) Notwithstanding section 17 of chapter 138 of the General Laws or any  
2 other general or special law to the contrary, the licensing authority of the Town of Watertown  
3 may grant 15 additional licenses for the sale of all alcoholic beverages to be drunk on the  
4 premises under section 12 of said chapter 138, subject to the conditions set forth in this act.

5           The following 4 licenses may only be granted as shown on the map entitled “Watertown  
6 Proposed Liquor License Specific Locations” dated December, 2014, a copy of which is on file  
7 in the office of the Watertown town clerk;

8           1 for premises located at 321 Arsenal Street, currently the Arsenal Center for the Arts;

9           1 for the approved project located at 202 Arsenal Street, for a restaurant use;

10 1 for the approved project located at 570 Arsenal Street, for hotel/restaurant use;

11 1 for the approved project located at 60 Howard Street, for a restaurant use;

12 The following 11 licenses for economic development purposes, as follows:

13 A maximum of 2 licenses for premises located within the Watertown Square or Coolidge  
14 Square area, the boundaries of which shall be as shown on a map entitled “Watertown Proposed  
15 Liquor License Area Locations,” dated December, 2014, a copy of which is on file in the office  
16 of the Watertown town clerk;

17 A minimum of least 1 license for premises located within the West End Riverfront area  
18 of Pleasant Street, as defined by the Strategic Framework for Economic Development adopted by  
19 the Watertown Town Council in August of 2011, and also shown on a map entitled “Watertown  
20 Proposed Liquor License Area Locations,” dated December, 2014, a copy of which is on file in  
21 the office of the Watertown town clerk;

22 The other licenses for premises located within the areas of the Arsenal Mall and the  
23 Watertown Mall, the boundaries of which shall be as shown on said map entitled “Watertown  
24 Proposed Liquor License Area Locations,” and the five economic development target areas  
25 defined by said Strategic Framework for Economic Development, and also shown on said map.

26 (b) Once a license is granted pursuant to this act, the licensing authority shall not  
27 approve the transfer of such license to any other location, but it may grant the license to a new  
28 applicant at the same location if the applicant files with the licensing authority a letter from the  
29 department of revenue indicating that the license is in good standing with the department and  
30 that all applicable taxes have been paid. No license granted hereunder may be sold or otherwise

31 transferred for financial consideration; and the granting of a license to a new applicant, as  
32 provided for herein, shall be the sole method by which a license holder may be changed.

33 (c) Notwithstanding said section 12 of said chapter 138, the licenses authorized by this  
34 act shall be subject to a supplemental annual fee, to be set by the town council, in addition to the  
35 annual fee for existing alcoholic beverage licenses in the Town of Watertown, but not to exceed  
36 two times the amount payable for such an existing license for the applicable license year. The  
37 additional revenue from these fees shall be deposited into an economic development account in  
38 the Town of Watertown and be expended consistent with the purposes of that account.

39 (d) If a license granted under this act is cancelled, revoked or no longer in use, it shall be  
40 returned physically, with all legal rights, privileges and restrictions pertaining thereto, to the  
41 licensing authority and the licensing authority may then grant the license to a new applicant  
42 under the same conditions as specified under this act.

43 SECTION 2. This act shall take effect upon its passage.
