An Act relative to fentanyl.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Section 32E of chapter 94C of the General Laws, as appearing in the 2014 Official
- 2 Edition, is hereby amended by inserting in subsection (b), in line 42, after the words, “paragraph
- 3 (a)”, the following:— clause (6) of paragraph (b),
