An Act establishing the rank of first lieutenant of the state police.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 1 of chapter 22C of the General Laws, as appearing in the 2014
2 Official Edition, is hereby amended by inserting after the word “lieutenant”, in line 7, the second
3 time it appears, the following words:- , first lieutenant.

4 SECTION 2. Section 3 of said chapter 22C, as so appearing, is hereby amended by
5 inserting after the word “sections”, in line 8, the following word:- , stations.

6 SECTION 3. Said chapter 22C is hereby further amended by inserting after section 8 the
7 following section:-

8 Section 8A. The colonel shall designate a head of each station and unit, who shall hold
9 the temporary rank of first lieutenant; provided, however, that the rank of first lieutenant shall
10 only apply for the duration of a person’s position as head of the station or unit. A first lieutenant
11 shall be a person currently employed by the department in the rank of lieutenant and shall be

- 12 compensated at the same rate as a person employed by the department in the rank of detective
- 13 lieutenant.
