An Act Pardon.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 PARDON REPORT — 2015
- 2 ALLAH, TRUE-SEE, of the following offenses:
- 3 April 11, 1988, Boston Municipal Court:
- 4 Possession of a Class D Substance.
- 5 Guilty, 1 year probation.
- 6 March 23, 1989, Boston Municipal Court:
- 7 Receiving Stolen Property.
- 8 Continued without a finding, 5 months probation.
- 9 October 10, 1989, Suffolk Superior Court:
- 10 Unlawful Possession of a Firearm.

11 Guilty, 2 years committed, 1 year to serve with the balance of the sentence suspended for
12 2 years.

13 October 10, 1989, Suffolk Superior Court:

14 Unlawful Possession of Ammunition.

15 Guilty, filed.

16 July 2, 1990, Suffolk Superior Court:

17 Armed Assault with Intent to Murder.

18 Guilty, 9 to 10 years committed.

19 July 2, 1990, Suffolk Superior Court:

20 Assault & Battery by Means of a Dangerous Weapon.

21 Guilty, 9 to 10 years committed.

22 June 26, 2014, Advisory Board of Pardons recommended a pardon.

23 Pardoned of the above offenses on January 2, 2015.

25 SCHOOLCRAFT, THOMAS K., of the following offense:

26 October 4, 2005, Newburyport District Court:

27 Breaking & Entering in the Nighttime with the Intent to Commit a Felony
