An Act relative to Board of Elementary and Secondary Education accountability.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 1E of chapter 69 of the General Laws, as appearing in the 2012  
2 Official Edition, is hereby amended by striking, in lines 32 through 34, inclusive, the following  
3 words “A copy of said frameworks shall be submitted to the joint committee on education, arts  
4 and humanities at least sixty days prior to taking effect.” and inserting in place thereof the  
5 following:- A copy of said frameworks shall be submitted to the joint committee on education  
6 and the general court for final approval prior to taking effect.
