Ehrlich and others for legislation to reduce plastic bag pollution, reports recommending that the accompanying bill (House, No. 4168) ought to pass.

In the One Hundred and Eighty-Ninth General Court (2015-2016)

An Act to reduce plastic bag pollution.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. The General Laws are hereby amended by inserting after chapter 210 the
- 2 following chapter:
- 3 CHAPTER 21P: The Plastic Bag Reduction Act.
- 4 Section 1. "Postconsumer recycled material" means a material that would otherwise be
- 5 destined for solid waste disposal, having completed its intended end use and product life cycle.
- 6 Postconsumer recycled material does not include materials and byproducts generated from, and
- 7 commonly reused within, an original manufacturing and fabrication process.
- 8 "Recycled paper bag" means a paper bag that is 100 per cent recyclable and displays the
- 9 words "Reusable" and "Recyclable" in a highly visible manner on the outside of the bag.
- "Reusable grocery bag" a bag with handles that is specifically designed and
- manufactured for at least 175 uses and is made of industrial vinyl, or made of cloth or other
- machine washable fabric.

- "Single-use carryout bag" means a bag made of plastic, paper, or other material that is provided by a store to a customer at the point of sale and that is not a recycled paper bag or a reusable grocery bag.
 - (1) A single-use carryout bag does not include either of the following:
- (A) A bag provided by a pharmacy to a customer purchasing a prescription medication.
- (B) A non-handled bag used to protect items from damaging or contaminating other purchased items placed in a recycled paper bag, a reusable grocery bag, or a compostable plastic bag.
 - (C) A bag provided to contain an unwrapped food item.

- (D) A non-handled bag that is designed to be placed over articles of clothing on a hanger.
 - "Store" means a retail establishment with gross interior space of 3000 square feet or larger, exclusive of stockroom, office, storage and other space ancillary of a publicly accessible space intended to be frequented by consumers, or at least three (3) locations under the same ownership or brand name within the Commonwealth.
 - Section 2. (a) Except as provided in this section on and after August 1, 2018, a store shall not provide a single-use carryout bag to a customer at the point of sale.
 - (b) From the date of this legislation's enactment until August 1, 2018, a store may make available for purchase at the point of sale a single-use carryout bag, reusable grocery bag, or recycled paper bag. A store that makes single-use carryout bags, reusable grocery bags, or recycled paper bags available for purchase prior to August 1, 2018 shall not sell the single-use carryout bag, reusable grocery bag, or recycled paper bag for less than ten cents (\$0.10).

- 34 (c) On and after August 1, 2018, a store may make available for purchase a recycled 35 paper bag, for a charge of no less than ten cents (\$0.10).
 - (d) On and after August 1, 2018, a store may make available for purchase a reusable grocery bag, for a charge of no less than \$0.10.

- (e) All moneys collected pursuant to this article shall be retained by the store.
- (f) The department of environmental protection shall promulgate regulations with regard
 to the enforcement of this chapter.
- Section 3. Nothing in this chapter shall preempt further limitation of single-use carryout bags by the commonwealth or any political subdivision of the commonwealth, provided however that any existing ordinance or by-law is not grandfathered in under this chapter.
