4   2869, 2870, 2872, 2873, 2874, 2875, 2876, 2877, 2879, 2880, 2882, 2883, 2884, 2885, 2886,  
5   2887, 2890, 2891, 2892, 2893, 2894, 2896, 2897, 2898, 2899, 2900, 2902, 2903, 2905, 2906,  
6   2907, 2908, 2910, 2911, 2912, 2913, 2914, 2915, 2916, 2917, 2918, 2919, 2920, 3306, 3307,  
7   3309, 3310, 3525, 3527, 3528, 3530, 3531, 3533, 3534, 3579, 3724 and 3776, relative to  
8   telecommunications, utilities and energy issues.

9           Said committee shall report to the General Court the results of its investigation and study  
10   and its recommendations, if any, together with drafts of legislation necessary to carry such  
11   recommendations into effect, by filing the same with the Clerk of the House of Representatives  
12   on or before December 31, 2016.
