The Commonwealth of Massachusetts

In the One Hundred and Eighty-Ninth General Court (2015-2016)

An Act requiring a "Made in Massachusetts" logo to be included in on screen credits for movies filmed in Massachusetts.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1	SECTION 1. Subsection (1) of section 6 of chapter 62 of the General Laws, as appearing
2	in the 2014 Official Edition, is hereby amended by adding the following paragraph:

3 (9) A feature-length motion picture that is eligible for a credit pursuant to paragraph (3) 4 shall display a credit and a logo approved by the Massachusetts film office, in consultation with 5 the commissioner, stating that the feature-length motion picture was made in Massachusetts. For 6 feature-length motion pictures for which 100 percent of the total production expenses are 7 Massachusetts production expenses or for which 100 percent of the total principal photography 8 days take place in the commonwealth, the credit and logo shall include the following title: "Made 9 in Massachusetts". For feature-length motion pictures for which Massachusetts production 10 expenses exceed 50 percent, but are less than 100 percent, of the total production expenses or for 11 which principal photography days taking place in the commonwealth exceed 50 percent, but are 12 less than 100 percent, of the total principal photography days, the credit and logo shall include 13 the following title: "Made in Part in Massachusetts".

SECTION 2. Section 38X of chapter 63 of the General Laws, as so appearing, is hereby
amended by inserting at the end thereof the following subsection:

16 (h) A feature-length motion picture that is eligible for a credit pursuant to subsection (c) 17 shall display a credit and a logo approved by the Massachusetts film office, in consultation with 18 the commissioner, stating that the feature-length motion picture was made in Massachusetts. For 19 feature-length motion pictures for which 100 percent of the total production expenses are 20 Massachusetts production expenses or for which 100 percent of the total principal photography 21 days take place in the commonwealth, the credit and logo shall include the following title: "Made 22 in Massachusetts". For feature-length motion pictures for which Massachusetts production 23 expenses exceed 50 percent, but are less than 100 percent, of the total production expenses or for 24 which principal photography days taking place in the commonwealth exceed 50 percent, but are 25 less than 100 percent, of the total principal photography days, the credit and logo shall include 26 the following title: "Made in Part in Massachusetts".
