In the One Hundred and Eighty-Ninth General Court (2015-2016)

An Act authorizing the town of Acton to grant 16 additional licenses for the sale of all alcoholic beverages and 6 additional licenses for the sale of wines and malt beverages to be drunk on the premises.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1	SECTION 1. (a) Notwithstanding section 17 of chapter 138 of the General Laws, the
2	licensing authority of the town of Acton may grant 9 additional licenses for the sale of all
3	alcoholic beverages to be drunk on the premises pursuant to section 12 of said chapter 138 and 4
4	additional licenses for the sale of wines and malt beverages to be drunk on the premises pursuant
5	to said section 12 of chapter 138, to locations to be determined by the licensing authority in
6	accordance to this section. The licenses shall be subject to all of said chapter 138 except said
7	section 17.

(b) The licensing authority of the town of Acton shall restrict the licenses authorized by
this section in the following manner: 5 licenses for the sale of all alcoholic beverages and 2
licenses for the sale of wines and malt beverages to be drunk on the premises pursuant to said
section 12 of said chapter 138 shall be restricted to entities located within the Kelley's Corner,
West Acton Village and Village Residential districts; 2 licenses for the sale of all alcoholic

13 beverages and 1 license for the sale of wines and malt beverages to be drunk on the premises 14 pursuant to said section 12 of said chapter 138 shall be restricted to entities located within the Limited Business and East Acton Village districts ; 2 licenses for the sale of all alcoholic 15 16 beverages and 1 license for the sale of wines and malt beverages to be drunk on the premises 17 pursuant to said section 12 of said chapter 138 shall be unrestricted and available to entities 18 located anywhere within Acton where restaurants are allowed or permitted by zoning. 19 (c) Notwithstanding sections 12 and 77 of said chapter 138, the licensing authority may 20 restrict the licenses issued pursuant to this section to holders of common victualler licenses. 21 (d) The licensing authority may approve the transfer of any license issued pursuant to this 22 section to another location provided that the license shall remain subject to the location 23 restriction set forth in subsection (b) that applied to such license as initially issued. 24 (e) If any license granted under this section is cancelled, revoked, or no longer in use, it 25 shall be returned physically, with all of the legal rights, privileges and restrictions pertaining 26 thereto, to the licensing authority which may then grant the license to a new applicant under the 27 same conditions as specified in this section provided that the applicant files with the licensing 28 authority a letter from the department of revenue and a letter from the department of 29 unemployment assistance indicating that the licensee is in good standing with those departments 30 and that all applicable taxes, fees and contributions have been paid. 31 SECTION 2. (a) Notwithstanding section 17 of chapter 138 of the General Laws, the 32 licensing authority of the town of Acton may grant 7 additional licenses for the sale of all 33 alcoholic beverages to be drunk on the premises pursuant to section 12 of said chapter 138 and 2 34 additional licenses for the sale of wines and malt beverages to be drunk on the premises pursuant

to said section 12 of chapter 138, to locations to be determined by the licensing authority in
accordance to this section. The licenses shall be subject to all of said chapter 138 except said
section 17.

38 (b) The licensing authority of the town of Acton shall restrict the licenses authorized by 39 this section in the following manner: 3 licenses for the sale of all alcoholic beverages and 1 40 license for the sale of wines and malt beverages to be drunk on the premises pursuant to said 41 section 12 of said chapter 138 shall be restricted to entities located within the Kelley's Corner, 42 West Acton Village and Village Residential districts; 2 licenses for the sale of all alcoholic 43 beverages to be drunk on the premises pursuant to said section 12 of said chapter 138 shall be 44 restricted to entities located within the Limited Business and East Acton Village districts; 2 45 licenses for the sale of all alcoholic beverages and 1 license for the sale of wines and malt 46 beverages to be drunk on the premises pursuant to said section 12 of said chapter 138 shall be 47 unrestricted and available to entities located anywhere within Acton where restaurants are 48 allowed or permitted by zoning.

- 49 (c) Notwithstanding sections 12 and 77 of said chapter 138, the licensing authority may
 50 restrict the licenses issued pursuant to this section to holders of common victualler licenses.
- (d) The licensing authority may approve the transfer of any license issued pursuant to this
 section to another location provided that the license shall remain subject to the location
 restriction set forth in subsection (b) that applied to such license as initially issued.

(e) If any license granted under this section is cancelled, revoked, or no longer in use, it
shall be returned physically, with all of the legal rights, privileges and restrictions pertaining
thereto, to the licensing authority which may then grant the license to a new applicant under the

57	same conditions as specified in this section provided that the applicant files with the licensing
58	authority a letter from the department of revenue and a letter from the department of
59	unemployment assistance indicating that the licensee is in good standing with those departments
60	and that all applicable taxes, fees and contributions have been paid.
61	SECTION 3. Section 1 of this Act shall take effect upon passage.
62	SECTION 4. Section 2 of this Act shall take effect on January 1, 2018 or upon the

63 issuance of all licenses as allocated under section 1 of this act.
