**In the One Hundred and Eighty-Ninth General Court
(2015-2016)**

An Act relative to prevailing wages.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1.

2 Section 26 of Chapter 149 of the General Laws, as appearing in the 2014 Official Edition,
3 is hereby amended by inserting after words "pension plans", in line 46, the following: - ", bona
4 fide apprenticeship and training programs approved by the commonwealth which comply with
5 the requirements of Sections 11E to 11L, inclusive, of Chapter 23 of the General Laws,".

6 SECTION 2.

7 Section 27 of Chapter 149 of the General Laws, as so appearing, is hereby amended by
8 inserting after the words "pension plans", in line 44, the following: ", bona fide apprenticeship
9 and training programs approved by the commonwealth which comply with the requirements of
10 sections 11E to 11L, inclusive, of Chapter 23 of the General Laws,".

11 SECTION 3.

12 Said section 27 of Chapter 149, as so appearing, is hereby amended by inserting after the
13 words "pension plan" the following:- ", a bona fide apprenticeship and training program
14 approved by the commonwealth which comply with the requirements of sections 11E to 11L,
15 inclusive, of Chapter 23 of the General Laws,".

16 SECTION 4.

17 Said section 27 of Chapter 149, as so appearing, is hereby amended by inserting after the
18 words "health and welfare funds", in line 54, the following:- ", bona fide apprenticeship and
19 training programs approved by the commonwealth which comply with the requirements of
20 sections 11E to 11L, inclusive, of Chapter 23 of the General Laws,".

21 SECTION 5.

22 Said section 27 of Chapter 149, as so appearing, is hereby amended by inserting after the
23 words "welfare funds", in lines 60 to 61, the following:- ", bona fide apprenticeship and training
24 programs approved by the commonwealth which comply with the requirements of sections 11E
25 to 11L, inclusive, of Chapter 23 of the General Laws".

26 SECTION 6.

27 Said section 27 of Chapter 149, as so appearing, is hereby amended by inserting after the
28 words "welfare funds", in line 74, the following:- ", bona fide apprenticeship and training
29 programs approved by the commonwealth which comply with the requirements of sections 11E
30 to 11L, inclusive, of Chapter 23 of the General Laws,".

31 SECTION 7.

32 Said section 27 of Chapter 149, as so appearing, is hereby amended by inserting after the
33 words "welfare funds", in line 80, the following:- ", bona fide apprenticeship and training
34 programs approved by the commonwealth which comply with the requirements of sections 11E
35 to 11L, inclusive, of Chapter 23 of the General Laws".

36 SECTION 8.

37 Said section 27 of Chapter 149, as so appearing, is hereby amended by inserting after the
38 words "welfare funds", in line 90, the following:- ", bona fide apprenticeship and training
39 programs approved by the commonwealth which comply with the requirements of sections 1B to
40 11L, inclusive, of Chapter 23 of the General Laws".
