1           *Ordered,* That the committee on Education be authorized to sit during a recess of the  
2 General Court to make an investigation and study of House documents numbered 328, 337, 355,  
3 357, 368, 369, 382, 399, 421, 456, 477, 496, 502, 509 and 510, relative to school climate, safety,  
4 and student discipline and vocational technical education, collaboratives, and regional schools.

5           Said committee shall report to the General Court the results of its investigation and study  
6 and its recommendations, if any, together with drafts of legislation necessary to carry such  
7 recommendations into effect, by filing the same with the Clerk of the House of Representatives  
8 on or before December 31, 2016.
