2   General Court to make an investigation and study of House documents numbered 1894, 1896,  
3   1902, 1904, 1905, 1907, 1921, 1944, 1961, 1962, 1965, 1970, 1979, 1986, 1991, 2003, 2012,  
4   2022, 2029, 2033, 2035, 2070, 2072, 2073, 2079, 3465, 3468 and 3471, relative to public health  
5   matters.

6           Said committee shall report to the General Court the results of its investigation and study  
7   and its recommendations, if any, together with drafts of legislation necessary to carry such  
8   recommendations into effect, by filing the same with the Clerk of the House of Representatives  
9   on or before December 31, 2016.
