An Act relative to education standards.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           The 2010 vote of the State Board of Elementary and Secondary Education adopting  
2 national education standards; i.e. the Common Core standards in English language arts and  
3 mathematics, is hereby nullified, and furthermore the state of Massachusetts shall now use its  
4 own assessment based on the state’s own curriculum frameworks as the standard for scholastic  
5 achievement in Massachusetts. In addition, The Department of Elementary and Secondary  
6 Education shall conduct an examination of academic standards and then update and revise the  
7 existing frameworks and MCAS assessment. As part of the examination process, the governor  
8 shall appoint a special commission to be chaired by the lieutenant governor and whose members  
9 will consist of educators, teachers, administrators, school committee members, parents of  
10 students, and concerned citizens. That commission shall provide input and assist DESE in  
11 developing new standards that shall be submitted to the State Board of Elementary and  
12 Secondary Education for final approval and adoption.
