By Mr. Day of Stoneham, a petition (accompanied by bill, House, No. 647) of Michael S. Day and others for legislation to increase access to recycling in the Commonwealth. Environment, Natural Resources and Agriculture.

The Commonwealth of Massachusetts

**In the One Hundred and Eighty-Ninth General Court
(2015-2016)**

An Act to increase access to recycling.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 An Act to increase access to recycling

2 “Recyclable” or “Recyclable Material” means a material that has the potential to be
3 recycled and which is pre-sorted Such materials shall include but are not limited to: 1)
4 containers, films and wraps made from metal, glass, plastic or paper and 2) newspaper, office
5 paper, cardboard and other grades of paper.

6 “Recycle” or “Recycling” means to recover materials or by-products which are: reused,
7 used as an ingredient or a feedstock in an industrial or manufacturing process to make a
8 marketable product: or use in a particular function or application as an effective substitute for a
9 commercial product or commodity. “Recycle” or “Recycling” does not mean to recover energy
10 from the combustion of material.

11 Recyclable or Recyclable Material means a material that has the potential to be recycled
12 and

13 which is pre-sorted. Recyclable material includes biodegradable paper, but does not
14 include:

15 (a) organic materials that will be composted or converted; or

16 (b) construction and demolition waste unless it has been separated and kept separate into
17 at least the following categories: asphalt, brick and concrete; ceiling tiles; wood; metals;
18 plaster and wallboard; roofing materials; and carpet.

19 Recycle or Recycled means to recover materials or by-products which will be:

20 (a) reused;

21 (b) used as an ingredient or a feedstock in an industrial or manufacturing process to make
22 a marketable product; or

23 (c) used in a particular function or application as an effective substitute for a commercial
24 product or commodity.

25 Recycle does not mean to recover energy from the combustion of a material or to create a
26 fuel.

27 Recycle does not include composting or conversion.

28 Restricted Material means any material subject to a waste restriction at a solid waste
29 management facility pursuant to 310 CMR 19.017(3).

30 Post-consumer Recyclables means the following materials which have served their
31 intended end

32 use and have been pre-sorted:

33 (a) containers, films and wraps and other forms of packaging made from metal, glass,
34 plastic or paper; and

35 (b) newspaper, office paper, cardboard and other grades of paper.

36 “Transport” means the movement, by vessel or carrier, of solid waste from the point of
37 generation to ultimate disposal, or any intermediate point for storage, reuse, treatment, or
38 recycling.

39 Chapter 21H of the General Law is hereby amended by inserting the following section
40 after Section 8.

41 SECTION 9: In order to reduce solid waste and its associated management and disposal
42 costs, protect the environment and provide citizens increased access to recycling, all cities and
43 towns in the Commonwealth providing curbside waste removal are required to also provide
44 curbside pickup of recyclable material. All cities and towns in the Commonwealth providing a
45 site or facility for waste drop-off are required to offer recycling at that site or facility.

46 All materials set aside for recycling or placed in recycling containers shall be delivered to
47 recycling facilities. No person who transports solid waste shall knowingly mix recyclable
48 materials with solid waste destined for a solid waste transfer station or disposal facility. No
49 person who transports solid waste shall knowingly transport recyclable materials, whether mixed

50 with solid waste or pre-sorted, to a solid waste disposal facility or to a solid waste transfer
51 station.

52 All persons providing solid waste collection services in the Commonwealth of
53 Massachusetts shall also provide: single stream or dual stream recycling collection services to all
54 of their Massachusetts single-family and multi-family residential customers and all of their
55 commercial customers, including delivery of a container or containers for the purpose of storage
56 and collection of recyclables that is adequately sized for the customer's use such that recycling is
57 encouraged and disposal of recyclables is discouraged. The recyclables collection service shall
58 be provided at a frequency of not less than once every other week.
