An Act regarding spouses as caregivers.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 9 of Chapter 118E is hereby amended by adding in the second  
2 sentence of the second paragraph, after the words “requirements for Title XIX” the following  
3 new language:--

4           “Any program of home and community based services funded pursuant to the provisions  
5 of this chapter or pursuant to the provisions of chapter one hundred and eighteen G, in which  
6 family members are permitted to serve as paid caregivers, shall include spouses within the  
7 definition of family member.”
