An Act relative to auto insurance reinspection requirements.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 8G of chapter 26 of the General Laws is hereby amended by  
2 striking out the nineteenth paragraph.

3           SECTION 2. Section 34O of chapter 90 of the General Laws, as appearing in the 2004  
4 Official Edition, is hereby amended by striking out in lines 191 to 198, the words: provided,  
5 however, that for at least seventy-five per cent of those claims where the appraisal indicates that  
6 the cost of repairs will exceed four thousand dollars and at least twenty-five per cent of those  
7 claims where the appraisal indicates that the cost of repairs will be four thousand dollars or less,  
8 a licensed auto damage appraiser shall re-inspect the vehicle following completion of repairs and  
9 shall certify on the claim form that the work has been completed in accordance with an appraisal  
10 made pursuant to said regulations and inserting in place thereof the following: - provided,

11 however, that the commissioner may establish requirements for re-inspection by licensed damage  
12 appraisers during or following the completion of repairs. In cases where a completed work claim  
13 form is required, a licensed auto damage appraiser, shall certify that the work has been  
14 completed in accordance with an appraisal or repair order.

15 SECTION 3. Section 113O of chapter 175 of the General Laws is hereby amended by  
16 striking out in the third paragraph the words: provided, however, that for at least seventy-five per  
17 cent of those claims where the appraisal indicates that the cost of repairs will exceed four  
18 thousand dollars and at least twenty-five per cent of those claims where the appraisal indicates  
19 that the cost of repairs will be four thousand dollars or less, a licensed auto damage appraiser  
20 shall re-inspect the vehicle following completion of repairs and shall certify on the claim form  
21 that the work has been completed in accordance with an appraisal made pursuant to said  
22 regulations and inserting in place thereof the following:- provided, however, that the  
23 commissioner may establish requirements for re-inspection by licensed damage appraisers during  
24 or following the completion of repairs. In cases where a completed work claim form is required,  
25 a licensed auto damage appraiser, which may include a repair shop appraiser, shall certify that  
26 the work has been completed in accordance with an appraisal or repair order.
