**In the One Hundred and Eighty-Ninth General Court  
(2015-2016)**

An Act reducing the costs for small business.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 12 of chapter 156C of the General Laws, as appearing in the 2010  
2 Official Edition, is hereby amended by striking subsection (d) and inserting in place thereof the  
3 following:-

4 “(d) The fee for the filing of the certificate of organization required by subsection (a)  
5 shall be two hundred fifty dollars. The fee for the filing of the annual report required by  
6 subsection (c) shall be two hundred fifty dollars. Such fees shall be paid to the state secretary at  
7 the time the certificate of organization or the annual report is filed.”

8 SECTION 2. Section 1 shall be effective beginning January 1, 2016.
