# The Commonwealth of Massachusetts

In the One Hundred and Eighty-Ninth General Court (2015-2016)

An Act providing hearing aid coverage for persons with profound hearing loss.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1: Chapter 118E of the General Laws, as appearing in the 2012 Official

2 Edition, is hereby amended by inserting after section 9C the following section:-

3 Section 9D. (a) Definitions. As used in the section: (i) Hearing Aid shall mean any 4 wearable, non-disposable instrument or device, not including surgical implants, designed to aid 5 or compensate for impaired or diminished human hearing; and any part, attachments, or 6 accessories including earmolds but excluding batteries. In the event that any part of this 7 definition conflicts with the definition of a hearing aid in section 196 of chapter 112 of the 8 General Laws, this definition will take precedent for the purposes of this section. (ii) Profound 9 Hearing Loss shall mean a pure tone average of 91 decibels (dB) or greater at 500Hz, 1000 Hz, 10 and 2000 Hz. (iii) Related Services shall mean those services necessary to assess, select, and

11 appropriately adjust or fit the hearing aid to ensure optimal performance. (b) A health benefit 12 plan shall provide 80 percent coverage, subject to all applicable co-payments, coinsurance, 13 deductibles, and out-of-pocket limits, in the cost of one hearing aid and all related services per 14 hearing impaired ear, every 24 months for insured individuals with bilateral profound hearing 15 loss, which shall be prescribed by an audiologist or a hearing instrument specialist as defined in 16 section 196 of chapter 12 of the General Laws, and dispensed by an audiologist or a hearing 17 instrument specialist as defined in said section. (c) A health benefit plan shall not be required to 18 pay a claim filed by its insured for payment of the cost of a hearing aid under the coverage 19 required by subsection (2) of this section if less than 2 years prior to the date of the claim its 20 insured filed a claim for payment of cost of a hearing aid under the required coverage and the 21 claim was paid by any health benefit plan.
