**In the One Hundred and Eighty-Ninth General Court
(2015-2016)**

An Act revising the headlight/windshield wiper law.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 The first sentence of section 15 of chapter 85 of the General Laws, as appearing in
- 2 chapter 481 of the Acts of 2014, is hereby amended by adding at the end thereof the following
- 3 language :the words “ A penalty under this section shall not be a surchargeable offense under
- 4 section 113B of chapter 175.”
