An Act improving local decision making.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Chapter 17 of the General Laws, as appearing in the 2012 Official Edition,  
2 is hereby amended by inserting at the end thereof the following new section:-

3           7B. The department shall establish, conduct and maintain an annual program of education  
4 and training for members of local boards of health; provided, however, that the department shall  
5 consult with the Massachusetts Association of Boards of Health in the development of said  
6 program; provided, further, that the department may contract with the Massachusetts Association  
7 of Boards of Health to provide such education and training. All education and training courses  
8 shall be free of charge to board members and, to the extent practicable, be offered in various  
9 locations throughout the commonwealth.

10 SECTION 2. Chapter 21A of the General Laws, as appearing in the 2012 Official  
11 Edition, is hereby amended by inserting after section fifteen the following new section:-

12 15A. The department of environmental protection shall establish, conduct and maintain  
13 an annual program of education and training for members of local conservation commissions;  
14 provided, however, that the department shall consult with the Massachusetts Association of  
15 Conservation Commissions in the development of said program; provided, further, that the  
16 department may contract with the Massachusetts Association of Conservation Commissions to  
17 provide such education and training. All education and training courses shall be free of charge to  
18 commission members and, to the extent practicable, be offered in various locations throughout  
19 the commonwealth.

20 SECTION 3. Section 3 of chapter 23B of the General Laws, as appearing in the 2012  
21 Official Edition, is hereby amended by inserting at the end thereof the following new  
22 subsection:-

23 (w) establish, conduct and maintain an annual program of education and training for  
24 members of local planning boards and zoning boards of appeals; provided, however that the  
25 department shall consult with the Massachusetts Federation of Planning and Appeals Boards  
26 regarding in development of said program; provided, further, the department may contract with  
27 the Massachusetts Citizen Planning Training Collaborative at the University of Massachusetts to  
28 provide such education and training. All education and training courses shall be free of charge to  
29 board members and, to the extent practicable, be offered in various locations throughout the  
30 commonwealth.

31 SECTION 4. Section 8C of chapter 40 of the General Laws, as appearing in the 2012  
32 Official Edition, is hereby amended by inserting at the end thereof the following new paragraph:-

33 The members of the commission shall attend such training programs conducted or  
34 sponsored by the department of environmental protection under the provisions of section 15A of  
35 chapter 21A.

36 SECTION 5. Section 12 of chapter 40A of the General Laws, as appearing in the 2012  
37 Official Edition, is hereby amended by inserting at the end thereof the following new paragraph:-

38 The members of the board shall attend such training programs conducted or sponsored by  
39 the department of housing and community development under the provisions of section 3 of  
40 chapter 23B.

41 SECTION 6. Section 81A of chapter 41 of the General Laws, as appearing in the 2012  
42 Official Edition, is hereby amended by inserting at the end thereof the following new paragraph:-

43 The members of the board shall attend such training programs conducted or sponsored by  
44 the department of housing and community development under the provisions of section 3 of  
45 chapter 23B.

46 SECTION 7. Section 26 of chapter 111 of the General Laws, as appearing in the 2012  
47 Official Edition, is hereby amended by inserting after the fifth sentence the following new  
48 sentence:- The members of the board shall attend such training programs conducted or sponsored  
49 by the department of public health under the provisions of section 7B of chapter 17.
