In the One Hundred and Eighty-Ninth General Court (2015-2016)

An Act further regulating tanning facilities.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Section 207 of chapter 111 of the General Laws, as appearing in the 2012
- 2 Official Edition, is amended by inserting after the definition for "Board", in line 8, the following
- 3 definition: -
- 4 "Operator", a person employed and trained by the licensee to control the operation of a
- 5 tanning device in compliance with this section and sections 208 to 213, inclusive, and to assist
- 6 and instruct the public in the correct operation of the tanning facility and its equipment.
- 7 SECTION 2. Section 210 of said chapter 111, as so appearing, is hereby amended by
- 8 adding the following sentence at the beginning thereof:-

- No tanning facility shall employ a person under 18 years of age as an operator or permit an employee under 18 years of age to operate a tanning device.
- SECTION 3. Said chapter 111 is hereby further amended by striking out section 211, as
- so appearing, and inserting in place thereof the following section:-
- Section 211. No person under 18 years of age shall use a tanning device.
