## The Commonwealth of Massachusetts

In the One Hundred and Eighty-Ninth General Court (2015-2016)

An Act relative to the annual allowance for certain survivors of public retirees and employees.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1	SECTION 1. Option (d) of subdivision (2) of section 12 of chapter 32 of the General
2	Laws, as appearing in the 2012 official Edition, is hereby amended in line 219 by insert-ing after
3	the words "or \$500" the following words:- or \$750.
4	SECTION 2. Option (d) of subdivision (2) of section 12 of said chapter 32, as so appear-
5	ing, is hereby amended by inserting in Line 243 the following paragraph:-
6	Beginning July 1, 2015, the normal monthly member-survivor allowance provided for
7	under this option to a spouse of a deceased member shall not be less than \$750 for members of
8	the state teachers' and state employees' retirement system. The provisions of this paragraph
9	shall take effect for the members of a retirement system of any other political subdivision by a
10	majority vote of the board of such system and by the local legislative body. For the purpose of
11	this paragraph, local legislative body shall mean the board of selectmen for a town system, the
12	city council subject to the provisions of its charter for a city system, the county retirement board

13	advisory council for a county sys-tem, the regional retirement board advisory council for a
14	regional system, the district members for a district system and the governing body of an authority
15	for an authority system. Acceptance shall be deemed to have occurred upon the filing of a
16	certification of such vote with the commission.
17	SECTION 3. Sections 9 and 100 of said chapter 32, as so appearing, shall apply to the
18	surviving spouse of a member who remarried before July 1, 2000 and whose pension, upon
19	remarriage, was terminated or otherwise reduced under said sections 9 or 100 of said chapter 32.
20	SECTION 4. Option (d) of subdivision (2) of section 12 of said chapter 32, as so appear-
21	ing, shall apply to the spouse of a deceased member who remarried before July 1, 2000 and
22	whose pension, upon remarriage, was terminated or otherwise reduced under Op-tion (d) of
23	subdivision (2) of said section 12 of said chapter 32.
24	SECTION 5. Section 101 of said chapter 32, as so appearing, shall apply to the widow of
25	a member who remarried prior to July 1, 2000 and whose pension, upon remarriage, was
26	terminated or otherwise reduced under said section 101 of said chapter 32.
27	SECTION 6. This act shall be prospective from the effective date of this act and shall not
28	entitle any surviving spouse, spouse of a deceased member or widow to any retro-active benefits.
