An Act establishing a municipal gas tax reimbursement.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Chapter 64A is hereby amended by inserting after section 7A the following  
2 section:-

3 Section 7B. Any municipality of the commonwealth that buys any fuel on which an  
4 excise tax has been paid or is chargeable under this chapter and, which fuel has been purchased  
5 for its municipal consumption and use, shall be reimbursed the amount of said excise tax in the  
6 manner and subject to the conditions herein provided. All claims for reimbursement shall be filed  
7 with the commissioner of revenue and shall be made in such form and containing such  
8 information, and accompanied with supporting documentation, as the commissioner of revenue  
9 shall prescribe. The commissioner of revenue shall establish a quarterly calendar year schedule  
10 for the submission of claims by municipalities for reimbursement of such paid or chargeable fuel

11 excise taxes. No reimbursement for such excise tax paid shall be made for any claim submitted  
12 after 6 months from the date of the purchase of such fuel. The commissioner of revenue shall  
13 transmit all claims approved by him to the comptroller for certification, and the amount so  
14 approved and certified as aforesaid shall be paid forthwith from the proceeds of the excise tax  
15 levied under this chapter 64A, without specific appropriation. No claim for reimbursement for  
16 said excise tax shall be made by a municipality under sections 7 and 7A of this chapter, for fuel  
17 purchased during said period, to which a municipality is entitled to claim a reimbursement under  
18 this section.

19 SECTION 2. Section 13 of Chapter 64A of the General Laws, as appearing in the 2012  
20 Official Edition, is hereby amended by striking out the text “7 and 7A” in lines 3 and 9, and in  
21 each line inserting in place thereof, the following text:- “7, 7A and 7B”.
