In the One Hundred and Eighty-Ninth General Court (2015-2016)

An Act reducing the costs for small business.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Section 12 of chapter 156C of the General Laws, as appearing in the 2014 Official
- 2 Edition, is hereby amended by striking subsection (d) and inserting in place thereof the
- 3 following:-
- 4 "(d) The fee for the filing of the annual report required by subsection (c) shall be two
- 5 hundred fifty dollars. Such fee shall be paid to the state secretary at the time the annual report is
- 6 filed."
- 7 SECTION 2. Section 12 of chapter 156C of the General Laws, as appearing in the 2014
- 8 Official Edition, is hereby amended by striking subsection (d) and inserting in place thereof the
- 9 following:-

- 10 "(d) The fee for the filing of the certificate of organization required by subsection (a)
- shall be five hundred dollars. The fee for the filing of the annual report required by subsection (c)
- shall be two hundred fifty dollars. Such fees shall be paid to the state secretary at the time the
- certificate of organization or the annual report is filed."
- SECTION 3. Section 1 shall be effective upon passage of this act.
- SECTION 4. Section 2 shall be effective beginning January 1, 2016.
