Resolve relative to a special VFW Parkway master plan commission.

1           **Resolved**, SECTION 1. There shall be a special commission known as the VFW Master  
2 Plan Commission for the purpose of making an investigation and study relative to the  
3 development, maintenance and improvement of the Veterans of Foreign War Highway in the  
4 town of Dedham and the West Roxbury section of the City of Boston, beginning at the  
5 intersection with Washington Street and Providence Highway in the Town of Dedham and  
6 traveling through the West Roxbury section of the City of Boston to its eastern end at Centre  
7 street in the West Roxbury section of the City of Boston. The commission shall consist of the  
8 senator for Norfolk & Suffolk District; the representative from the 10th Suffolk District; the  
9 representative from the 11th Norfolk District, who shall serve as the chairs of the commission;  
10 the representative in congress from the 8th congressional district, the district 6 Boston city  
11 councilor; the chairman of the board of selectmen for the town of Dedham, the director of public  
12 works in the town of Dedham; the commissioner of the Boston Transportation Department, or a  
13 designee, the Secretary of Transportation, or a designee, the commissioner of the department of  
14 conservation and recreation or a designee, 3 persons to be appointed by mayor of the city of

15 Boston who shall be residents of the West Roxbury section of the City of Boston, 2 persons from  
16 the town of Dedham to be appointed by the Dedham Board of Selectmen, a member of the West  
17 Roxbury Business Association, and 2 business owners who businesses are located on the VFW  
18 Parkway.

19 The investigation and study shall include: (1) an evaluation of the pedestrian, public  
20 transit, and automobile network including traffic patterns, signage, and signaling; (2) an analysis  
21 of existing federal, state and local funding sources, including grants and loans; (3) an evaluation  
22 of both private and publicly owned land that may be used for active and passive recreational use;  
23 (4) potential beautification and aesthetic improvements to the parkway.

24 No member of the commission shall receive any compensation for services, nor shall a  
25 member be reimbursed for any travel expenses or actual expenses incurred in carrying out duties  
26 as a member of the commission.

27 The commission shall report the results of its investigation and study, together with its  
28 recommendations and drafts of a master plan for development, maintenance, and improvements  
29 to the VFW Parkway, by filing with the clerk of the Boston city council on or before June 30,  
30 2016 and with the clerks of the house of representatives and the senate, who shall forward the  
31 same to their respective committees on ways and means.
