An Act designating the commission on postpartum depression as the Ellen Story Commission on Postpartum Depression.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 The second paragraph of chapter 313 of the acts of 2010 is hereby amended by striking
- 2 out, in line 1, the word “commission” and inserting in place thereof the following words:-
- 3 legislative commission to be known as the Ellen Story Commission on Postpartum Depression.
