By Mr. Brownsberger, a petition (accompanied by bill, Senate, No. 650) of William N. Brownsberger and Lori A. Ehrlich for legislation to create a sexual assault climate survey for Massachusetts colleges and universities. Higher Education.

An Act creating a sexual assault climate survey for Massachusetts colleges and universities.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1	There shall be established a task force on sexual assault on college campuses, hereinafter
2	referred to as the task force. The task force shall be co-chaired by designees of the Commissioner
3	of Higher Education, the Attorney General, and the Commissioner of Public Health. In addition
4	to the co-chairs, the task force shall include a representative chosen by the Jane Doe Institute
5	(JDI), a representative chosen by the Boston Area Rape Crisis Center (BARCC), a representative
6	chosen by the Center for Hope and Healing (CHH) in Lowell, a representative chosen by Fenway
7	Health's Violence Recovery Program (VRP), a representative chosen by the Association of
8	Independent Colleges and Universities in Massachusetts (AICUM), the Senate President or his
9	designee, and the Speaker of the House or his designee.
10	The task force shall develop a sexual assault climate survey to be issued to college

10 The task force shall develop a sexual assault climate survey to be issued to college 11 students across Massachusetts with the goal of determining the prevalence and perceptions of 12 sexual assault on college campuses. The role of the task force in implementing the 13 aforementioned climate survey shall include, but not be limited to, the following: (i) designing 14 the survey questions and mode of implementation; (ii) determining which colleges shall receive 15 the survey; (iii) consulting college officials in order to optimize the survey; and (iv) any other 16 necessary role determined by the task force.

17 The survey shall be fully anonymous and shall not include any personally identifiable 18 information. The task force shall develop the survey using best practices from peer-reviewed 19 research measuring sexual violence and harassment. The survey shall be designed to gather, to 20 the possible, information about, but not be limited to, the following topics: (i) the incidence and 21 prevalence of sexual violence, dating violence, domestic violence, and stalking; (ii) students' 22 knowledge of institutional policies and procedures; (iii) if victims reported the violence, to whom 23 did they report, what response did they receive, and were they were informed of, or referred to, 24 local, State, on-campus, or national resources; (iv) contextual factors, such as whether force, 25 incapacitation, or coercion was involved; (v) demographic factors that could be used to identify 26 at-risk groups; and (v) whether the assailants were students. The task force shall develop the 27 survey not more than 1 year after the task force is first convened.

The Commissioner of Higher Education shall require colleges and universities, as deemed necessary by the task force, to ensure that an adequate, random, and representative sample of students enrolled at the institution completes the climate survey not later than 1 year after the task force has developed the final survey. In addition to the standardized questions developed by the task force, institutions completing the survey may request additional information from students that would increase the institutions' understanding of school climate factors unique to their campuses.

35 Each four-year college identified by the task force shall provide the individual responses 36 to the campus climate survey to the task force within 90 days of the administration of the survey. The task force shall analyze the sexual assault incident data and shall publish a report based on 37 38 the data, their deliberations, and any hearings they may conduct. The report shall be made 39 available for comment to participating colleges and universities as well as the Association for 40 Independent Colleges and Universities of Massachusetts (AICUM) at least 30 days prior to 41 publication, and the task force shall consider revisions to the report in response to suggestions 42 and concerns raised by participating colleges. After revisions have been finalized, the task force 43 shall file the report with the Commissioner of Higher Education.

Following the filing of the report, the task force shall convene to determine future steps.
These steps may include, but not be limited to: (i) revising and modifying the original climate
survey as the task force deems necessary; (ii) determining that a similar survey shall be
implemented repeatedly, at an interval to be determined by the task force; (iii) making
recommendations for interventions to reduce the likelihood of sexual assault based on the results
of the survey; or (iv) any additional further steps deemed necessary by the task force.
