An Act updating the definition of felony larceny.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. The first paragraph of section 30 of chapter 266 of the General Laws, as  
2 appearing in the 2012 Official Edition, is amended by striking out, in line 8, the words “two  
3 hundred and fifty dollars” and inserting in place thereof the following words:-

4           one thousand three hundred dollars.

5           SECTION 2. Said first paragraph of section 30 of said chapter 266, as so appearing, is  
6 further amended by striking out, in lines 12-13, the words “two hundred and fifty dollars” and  
7 inserting in place thereof the following words:-

8           one thousand three hundred dollars.

9           SECTION 3. The fifth paragraph of said section 30 of said chapter 266, as so appearing,  
10 is amended by striking out, in line 73, the words “two hundred and fifty dollars” and inserting in  
11 place thereof the following words:-

12           one thousand three hundred dollars.

13           SECTION 4. Said fifth paragraph of said section 30 of said chapter 266, as so appearing,  
14 is hereby further amended by striking out, in line 77, the words “two hundred and fifty dollars”  
15 and inserting in place thereof the following words:-

16           one thousand three hundred dollars.

17           SECTION 5. Section 37C of said chapter 266, as so appearing, is amended by striking  
18 out, in line 11, the words “two hundred fifty dollars” and inserting in place thereof the following  
19 words:-

20           one thousand three hundred dollars.

21           SECTION 6. Said Section 37C of said chapter 266, as so appearing, is hereby further  
22 amended by striking out, in line 16, the words “two hundred fifty dollars” and inserting in place  
23 thereof the following words:-

24           one thousand three hundred dollars.

25           SECTION 7. Section 37C of said chapter 266, as so appearing, is hereby further amended  
26 by striking out, in line 22, the words “two hundred fifty dollars” and inserting in place thereof  
27 the following words:-

29           SECTION 8. Said section 37C of said chapter 266, as so appearing, is hereby further  
30 amended by striking out, in lines 29-30, the words “two hundred fifty dollars” and inserting in  
31 place thereof the following words:-

33           SECTION 9. Section 60 of said chapter 266, as so appearing, is amended by striking out,  
34 in lines 6-7, the words “two hundred and fifty dollars” and inserting in place thereof the  
35 following words:-

36           one thousand three hundred dollars.

37           SECTION 10. Said section 60 of said chapter 266, as so appearing, is hereby further  
38 amended by striking out, in lines 10-11, the words “two hundred and fifty dollars” and inserting  
39 in place thereof the following words:-

40           one thousand three hundred dollars.

41           SECTION 11. Section 127 of said chapter 266, as so appearing, is amended by striking  
42 out, in lines 12-13, the words “two hundred and fifty dollars” and inserting in place thereof the  
43 following words:-
