In accordance with the provisions of Section 4, subsection 2KKK of Chapter 4 of the Acts of 2003 I am submitting to you the Barnstable Registry of Deeds' plan for an expenditure of funds currently held in the County Registers Technological Fund. I ask that you refer this request to the Committees on Ways and Means and Post Audit and Oversight in the manner established to comply with the provisions of the above referenced Act.

Consistent with the provisions of said Act the proposed expenditures are for the purposes of technological improvements at the Barnstable Registry of Deeds. The proposed plan is consistent with the Registry's submitted IT profile and the Registry of Deeds Technology Advisory Committee Recommendations.

As required under the Act we have consulted with the Commonwealth's Chief Information Officer and with the Secretary of State and their respective assents are enclosed.

The specific proposed expenditure, totaling \$35,000.00 is based on dealing with our plan as set out in our IT profile. Our proposed expenditure is as follows:

- 1) Purchase, installation and ongoing maintenance of a camera surveillance system in the public recording and records areas of the Barnstable Registry of Deeds. Estimated Cost & Amount of Request \$35,000.00.
