

Executive Summary

The Office of Performance Management & Oversight (OPMO) oversees the effectiveness, accountability, and transparency of economic development efforts across the state. The OPMO was created by Chapter 240 of the Acts of 2010 – An Act Relative to the Economic Development Reorganization. It includes all public and quasipublic* entities engaged in economic development and any private organizations under contract with the Commonwealth to perform economic development services. The nineteen organizations under this office provide a wide range of services and programs that drive economic development.

This report and the reports from the nineteen organizations under the OPMO are filed with the clerks of the Senate and House of Representatives, the Chairs for the House and Senate Committees on Ways and Means and the House and Senate Chairs of the Joint Committee on Economic Development and Emerging Technologies. Agencies work closely with the Executive Office of Housing and Economic Development to create annual plans that align with the Commonwealth's economic development plan and policy – Choosing to Compete in the 21st Century. The plan includes five categories (below) identified as most important to drive the economy forward along with 55 action items to advance key initiatives.

- Advance Education and Workforce Development for Middle-Skill Jobs Through Coordination of Education, Economic Development, and Workforce Development Programs
- Support Innovation and Entrepreneurship
- Support Regional Development Through Infrastructure Investments and Local Empowerment
- Increase the Ease of Doing Business
- Improve Cost Competitiveness

^{*}Quasi-public agencies are state agencies created by statute that are funded to some extent with state tax dollars. They are headed by chief executive officers who report to boards of directors who in turn are appointed by state elected officials

Massachusetts has seen significant progress in all categories required for sustainable economic development and the improved collaboration across agencies has been an integral part of our success.

- Economic Growth —The Massachusetts economy grew at about twice the U.S. rate for 2007-2013
- **Job Growth** By January 2013, Massachusetts was the seventh state to regain its pre-recession job peak; outpacing most other states and the country as a whole. In 2013, Massachusetts added over 55,000 jobs, growing by more than one percent over the previous year. It was the most jobs added since 2000.
- **Population Growth** The U.S. Census reports that Massachusetts' population increased .72% from July 1, 2012 to July 1, 2013, the same rate of growth as the nation as a whole. The last time we matched the country's population growth was 1980.
- Housing Growth Total housing starts in Massachusetts in 2013 are twice the number of starts in 2011—14,538 versus 7,260. Total multi-family starts in 2013 are nearly three times those for 2011—7,601 versus 2,752. This represents the strongest year since 2007 for total starts, and the strongest since 2006 for multi-family starts.

We continue to refine our performance management process to include measurements that most accurately and comprehensively depict our progress. RESULTS

This section highlights some of the progress and accomplishments of the 19 economic development organizations under the Office of Performance and Management for Fiscal Year 2014. For comprehensive information on each agency, please visit the OPMO website – www.mass.gov/opmo.

The **Commonwealth Corporation** strengthens the skills of Massachusetts youth and adults by investing in innovative partnerships with industry, education, and workforce organizations. Commonwealth Corporation seeks to meet the immediate and emerging workforce needs of businesses and workers.

- Workforce Training Fund awarded \$13.4 million to 151 businesses to support the training of 11,508 workers
- Workforce Competitiveness Trust Fund awarded \$5 million to 15 businesses, educational, and workforce partnerships – these partnerships will train 850 individuals and represent engagement with over 100 businesses
- YouthWorks Program \$10 million to support 5,175 youth in summer employment experiences in 31 cities across the state
- Juvenile Justice Re-Entry Programs Bridging the Opportunity Gap (BOG) initiative provides comprehensive employability services including innovative and high quality career readiness, vocational and work-based training, industry certifications and subsidized employment experiences. The summer program served 161 youths and the year round program served 230.
- Health Care Workforce Transformation Fund awarded 51 grants totaling \$1.8 million to fund employee
 training and programs within the health care industry. Projects focused on adopting new methods of
 patient engagement, care coordination and the development and use of electronic health record systems.

The **Community Economic Development Assistance Corporation** provides technical assistance, predevelopment lending, and consulting services to non-profit organizations involved in housing development, workforce development, neighborhood economic development, and capital improvements to childcare facilities.

- Housing Finance and Development \$20.3 million was committed to 45 projects, supporting 2,429 housing units.
- Supportive Housing provides a combination of housing services to help people live more stable, productive lives. New loan commitments were awarded by Department of Housing and Community Development to 41 projects totaling \$30.5 million.
- Workforce Development delivered eight trainings, and held 16 peer-learning meetings across five state regions. Over 875 people attended the Commonwealth Workforce Coalition (CWC) events representing 378 organizations.
- The Children's Investment Fund committed \$1.8 million to six projects offering a full range of financing and technical advising services options for early education and after school programs.

The **Commonwealth Marketing Office** acts as a central entity and coordinating organization for marketing initiatives to advance economic development.

 Coordinated marketing and branding for the second annual Economic Development Summit held in April 2014 including a 16-page booklet that is available in digital format here.

- Created a "<u>Come Early, Stay Late</u>" campaign for the millions of conferences attendees visiting Massachusetts annually, encouraging them to stay extra time to enjoy Massachusetts' tourist attractions and providing a warm welcome to support the convention industry
- The new blog, MassItsAllHere.com, launched in January has posted 42 blog stories, 60 + events, and has enlisted guest bloggers to contribute.

The Massachusetts Business Development Corporation provides a loan guaranty program designed to target "main street" businesses with working capital and expansion financing.

- Job Creation and Retention projected 2,072 created and retained jobs
- Business Coverage assisted 261 'main street' businesses
- Financing provided \$15.6 million in private sector financing
- Regional Coverage 17% of all loans were to companies located in gateway cities
- Cost Efficiency state funds cost per job is \$264

The Massachusetts Clean Energy Center is dedicated to accelerating the success of clean energy technologies, companies, and projects in Massachusetts while creating high-quality jobs and long-term economic growth for the people of Massachusetts.

- MassCEC confirmed 88,372 clean energy workers, which represents an increase of 10.5% over FY2013. There are now 5,985 clean energy firms identified representing an increase from 5,557 the prior year.
- Innovate Mass helps clean energy companies and their technologies move closer to commercialization. Technology teams are eligible to receive up to \$150,000 in funds as long as it is matched by at least 50% outside funding. The Massachusetts technology teams receiving funding are:
 - Nuvera Fuel Cells (Billerica) \$150,000 matched by \$830,740
 - Sparkplug Power (Somerville) \$150,000 matched by \$223,000.
 - Black Island Wind Turbines (Amherst) \$150,000 matched by \$75,000
 - SolarOne Solutions (Needham) \$88,779 matched by \$57,772
- Incubate Mass-provides funding to new clean energy incubators. Awarded \$300,000 to provide earlystage clean energy companies with affordable office space
 - Greentown Labs (Somerville) \$190,000
 - North Shore InnoVentures (Beverly) \$60,000
 - Advanced Technology Manufacturing Center (Dartmouth) \$30,000
 - Scibelli Enterprise Center (Springfield) \$20,000
- Solarize Mass is a partnership between the Massachusetts Clean Energy Center (MassCEC), the Green Communities Division of the Massachusetts Department of Energy Resources (DOER) and cities and towns across the Commonwealth. It has led to more than 2,400 (up from 900) residents and business owners signing contracts for small-scale solar electricity systems. Solarize Mass increased the adoption of small-scale solar electricity through facilitated energy planning workshops in 46 (up from 27) municipalities and has installed 16 megawatts of solar.

- **Learn and Earn Program** awarded \$435,000 for the first round providing funding for programs to prepare high school students for higher learning opportunities and careers in clean energy and science, technology, engineering and math (STEM) fields.
 - o Brockton High School –Students will have the opportunity to earn college credit through Bridgewater State University's "Energy and its Social Uses" course.
 - o Greater Lawrence Technical School Students will train on ground-level, full-sized practice roofs and students will install a fully-functional solar electric system at the school as a final project.
 - Northeastern University and John D. O'Bryant School of Mathematics and Science This program
 will educate 25 students around clean energy topics, while providing support for high school
 students preparing to pass Advanced Placement calculus exams, which can earn students college
 credit.
- Internship Program- Since its inception in 2011, the Massachusetts Clean Energy Internship Program has placed hundreds of students and recent graduates at clean energy companies across the Commonwealth. Over the past three summers, the program has placed 871 students and recent graduates in internships at 224 clean energy companies across the state. As a result, more than 54 students gained full-time or part-time employment.

The Massachusetts Convention Center Authority generates significant regional economic activity by attracting conventions, tradeshows, and other events to its world-class facilities while maximizing the investment return for the residents and businesses in the Commonwealth of Massachusetts.

- **Economic Activity** \$570.2 million in economic activity, resulting in \$30.6 million in combined state and local taxes and supporting approximately 5,100 jobs
- World Class Events hosted 94 events: 34 education, 21 technology, and 39 medical/pharma events
- **Entrepreneurial Government** generated \$2.6 million through "entrepreneurial government" initiatives including leveraging non-revenue generating space to generate lease and advertising revenue
- Job Training the Community Partnership Program Fund receives ten cents for each square foot of rented exhibit space and one dollar per admission ticket sold for each gate show. This year \$120,000 was awarded to 26 programs focused on job skills training and career development particularly for youth.
- Innovation Leaderships invested \$2.6 million in technology upgrades including upgrading wireless capabilities to remain a technology leader in the convention industry
- Hospitality Scholarships- granted \$2,500 to four students in the hospitality/tourism industry.

The Massachusetts Cultural Council promotes excellence, access, education, and diversity in the arts, humanities, and interpretive sciences to improve the quality of life and contribute to the economic vitality of our communities.

GRANT PROGRAMS

- Adams Arts Program support through the disbursement of cultural economic development grants including grants for cultural activities that have the capacity to revitalize communities, stimulate income, create or enhance jobs, and attract tourism.
- Artist Fellowships fellowships to artists in recognition of exceptional work

- Big Yellow School Bus provides grants to help schools meet the costs of providing educational field trips to cultural institutions and events across the Commonwealth.
- Cultural Facilities Fund increases investments from both the public sector and the private sector to support the sound planning and development of cultural facilities in Massachusetts in partnership with MassDevelopment.
- **Cultural Investment Portfolio** the portfolio represents a partnership that will better position the cultural sector as vital components of Massachusetts' economy and the quality of life of our citizens.
- Local Cultural Council Program Local Cultural Councils serving every city and town in Massachusetts offer grants to projects benefiting their respective communities.
- STARS Residencies grants to schools for residencies of 3 days or more with teaching artists, scientists, scholars, or cultural organizations.
- **Re-Grant/Project Programs-** refer to federal programs such as Poetry Out Loud, New England Foundation for the Arts, and contributions made to MassHumanites.
- **Traditional Arts Apprenticeships** as part of the <u>Folk Arts and Heritage Program</u>, apprenticeships support the teaching of traditional arts that are specific to a particular folk group or ethnic community.
- YouthReach multi-year grants for partnerships that provide substantive arts activities for young people who are "at-risk."

The Massachusetts Development Finance Agency stimulates economic development and industrial growth, increases employment, builds communities, promotes prosperity and general welfare, and eradicates blight across the Commonwealth.

Advanced Manufacturing

- Financed 44 manufacturing projects with over \$46 million invested creating 6,341 permanent jobs and 8,983 construction jobs.
- <u>AMPitup!</u> an educational program that shows students, parents, guidance counselors, and teachers how to take advantage of the many great, highly skilled, well-paying advanced manufacturing jobs available in the state. Awarded 11 grants totaling \$108,950 that resulted in 33 events to promote manufacturing jobs. This included company tours, teacher professional development, and presentations to business leaders.

Innovation

- 9.5% increase in total housing production to support innovation and entrepreneurial activity
- 387 new and 1,234 in preserved rental-housing units

Regional Development

- o Invested \$375 million on 95 projects in Gateway cities over 3,000 new jobs projected
- Conducted economic development academies in Gardner, Haverhill, Kingston, Franklin, and Adams. Academies were widely attended with over 275 participants. Since 2012 there has been 13 academies completed.
- The number of municipalities that have completed Northeastern University's Economic Development Assessment Tool (EDSAT) has increased to 68 from 60 in 2013 and 51 in 2012.
 EDSAT provides practical tools for local governments to better prioritize and position themselves to attract industry, private investment, a sustainable tax base and high quality good-paying jobs

The Massachusetts Export Center (part of the Massachusetts Small Business Development Center) helps companies achieve success in global markets by developing and providing targeted, high-impact services delivered through a statewide network of international trade professionals.

- Conducted 175 training sessions attracting 4,989 attendees
- Clients reported over \$150 million in export sales as a direct result of the assistance provided.
- Clients increased their export sales by over 8.5%

The Massachusetts Growth Capital Corporation creates and maintains jobs, especially in low and moderate-income areas by providing financing to small business, women, and minority owned firms, growing industries, and manufacturing companies through community development efforts.

- Working Capital closed 32 loans totaling over \$11 million
- Management Assistance provided management assistance to 40 small businesses
- Micro Loans loaned intermediaries \$500,000 and provided turnaround assistance for 30 firms
- Bank Partnerships increased the number of bank participants to from 43 to 56
- Small Business Assistance Grants awarded grants to 18 businesses ranging from \$20,000 to \$65,000 for a total of \$700,000

The Massachusetts Life Sciences Center creates and retains jobs in the life sciences super cluster by stimulating workforce development, strengthening the life sciences infrastructure and ecosystem, and promoting our global competitiveness.

Career Development

- Awarded \$3.3 million to 35 schools across the state for the purchase of equipment and supplies to train students in life sciences technology and research
- Placed 443 interns within over 241 sponsor companies the Internship program has placed over 1,000 interns to date

- Awarded \$310,000 in grants to encourage STEM education in K-12 with a focus on demographics that are underrepresented in STEM fields
- Accelerator Loan Program provided nearly \$2.5 million in working capital to three early stage companies. The Accelerator Program has invested or committed to fund \$18.7 million in loans to 28 companies, which have generated more than \$180 million in additional equity or acquisition proceeds
- International Collaborative Industry Program the program provides a grant to the Massachusetts partner company and the international agency provides a grant to its country partner. Below are the awards from the first round.

- Capital Grant Program helps fund infrastructure projects from across the state. During the second round of competitive funding 11 new grants for 6 community colleges, 35 high schools, and 3 new Planning Grants were awarded, totaling more than \$50.5 million
- Tax Incentive Program awarded \$24 million in tax incentives to 32 life sciences companies creating more than 1,200 projected new jobs
- **Business Plan Competitions** Massachusetts Institute of Technology was awarded \$10,000 for their business plan competitions and MassChallenge was awarded \$100,000 at the "Platinum Level"

The Massachusetts Office of Business Development strengthens the Massachusetts economy by providing a highly responsive, pro-business climate that stimulates job and investment growth. By working directly with businesses as well as in collaboration with other agencies and key stakeholders, MOBD facilitates access to resources to help businesses thrive in Massachusetts.

- **Job Creation and Retention** MOBD projects 5,306 new jobs, 20,235 retained jobs and private investment of over \$1 billion.
- **Business Coverage** met with 851 businesses and 535 business partners (municipalities, regional economic development organizations, and other key stakeholders for business development.
- Programs
 - Economic Development Incentive Program (EDIP) MOBD oversees the EDIP, which represents a partnership between a business, a municipality, and the state. In exchange for investment and job commitments, the municipality and state may provide tax incentives to foster business expansion. The program assisted 37 companies creating 2,528 new jobs, retaining 3,244 jobs and private investment of \$960 million. Since the program was reformed in 2009, 175 projects have received approval, leading to the creation of 12,666 new jobs, retention of 38,901 existing jobs and leveraging of over \$4.6 billion in private investment

- Regional Economic Development Organization (REDO) Grant Program MOBD oversees the REDO program, which represents a partnership between MOBD and regional economic development organizations throughout the state. In FY14, 12 grants totaling \$850,000 were awarded to organizations across the state to provide a consistent and efficient response to businesses seeking assistance. REDO funds were used for regional market initiatives including workforce development and training, academic partnerships, advanced manufacturing, technical assistance, and innovation economy initiatives.
- Database Management MOBD consolidates pipeline and project information from the major business development agencies. This centralized collection point provides a comprehensive understanding of regional needs and outcomes across the Commonwealth.

The Massachusetts Office of International Trade and Investment expands the Massachusetts economy by marketing the state's business internationally, through focused export promotion, attracting foreign companies to invest in Massachusetts and handling protocol as it relates to trade and investment.

- Awarded \$720,856 to 71 companies as part of the STEP Grant Program, which provide grants to eligible
 Massachusetts small businesses to increase export sales of goods and services
- Held eight innovation partnership missions: United Arab Emirates, Israel, Panama, Mexico, Japan, Hong Kong, Singapore, and Canada
- Welcomed over 60 foreign trade delegations

The Massachusetts Office of Travel and Tourism markets Massachusetts as a destination for leisure travelers from domestic and international markets in order to generate state and local revenues and ultimately to grow and sustain jobs in the tourism sector.

- Provided \$7.5 million in 38 regional tourism grants to 22 organizations that provide services for tourism, convention, travel, and recreation
- MOTT's website, <u>massvacation.com</u>, is one of the top 20 global travel websites and ranks #2 of the 50 U.S.
 State Tourism Offices in digital and social media engagement. This year, MOTT's digital program measured over 700 million impressions.

The Massachusetts Port Authority operates an integrated transportation network that delivers world-class safety, security, facilities, and customer services in an environmentally responsible manner. Massport promotes economic growth and opportunity, enhances the quality of life of New England residents, and protects the freedom to travel safely, securely, efficiently and cost-effectively

- Safety and Security Received annual FAA Certifications; Increased camera coverage by adding 164 new cameras
- Customers Serviced 29.4 million aviation passengers at Logan Airport and 369,000 cruise passengers
- Facilities Improvement installed passenger information digital signage system in Terminal C and construction underway in Terminal E
- Concessions- Authority earned \$72.5 million in concessions revenue increasing 4.3 % over last year
- Airport and Air Service Expansion
 - Worcester Regional Airport JetBlue service began November 7, 2013.
 - Hanscom Airport Complete permitting and planning for new hanger being built by Rectrix
 - Logan Airport -Record 29.4 million total passengers serviced at Logan Airport in fiscal year 2013.
 - Logan Airport Added new airlines: COPA, Emirates, Turkish and Hainan Airlines services will contribute over \$580 million to the regional economy
- Maritime Operations Serviced 116,800 containers exceeding goal by 9%.

The Massachusetts Small Business Development Center (part of the University of Massachusetts) contributes to the entrepreneurial growth of small business throughout Massachusetts by providing high quality, in-depth advising, training, and capital access.

- Business Advisory Services provided advisory services to 3,459 individuals comprising over 22,493 hours
 of assistance. There are 874 clients located in Gateway Cities.
- Jobs created 489 new jobs and retained 619 jobs
- Training MSBDC's six regional offices and Mass Export conducted 175 training sessions.
- MSBDC 2013 Economic Impact Survey According to client responses businesses had \$131.7 million in new sales revenue adding \$9.77 million in total tax revenue.

The **Massachusetts Tech Collaborative** promotes new economic opportunity and fosters a more favorable environment for the formation, retention, and expansion of technology-related enterprises.

Innovation Institute

- 184 interns where placed within 118 companies. The majority of students placed in these internships were enrolled at schools such as Boston University, MIT, Northeastern University, the UMass campuses, and Worcester Polytechnic Institute (WPI)
- Awarded \$150,000 each to three mentorship programs to encourage innovation and entrepreneurship across the Commonwealth
 - E for All (formerly Merrimack Valley Sandbox)
 - Interise, Inc. South Coast

- Valley Venture Mentors Western Mass
- The Collaborative Research Matching Grant Program approved awards of \$7 million leveraging over \$28.7 million in matching funds

MassBroadband Institute

- o Installed 950 miles of new fiber optic cables
- o Installed equipment in nearly 800 facilities located in over 120 towns and cities.
- Awarded 46 small business technical assistance grants to incorporate internet technologies

Massachusetts eHealth Institute

- 2,376 Medicare Electronic Health Records (EHR) applications have been successfully processed for payment
- o \$55 million in Medicaid Meaningful Use Incentives have been distributed
- o Enrolled additional 107 providers in the Regional Extension Center

The **Massachusetts Technology Transfer Center** supports technology transfer activities from public and private research institutions to companies in Massachusetts resulting in the creation of more technology based companies and improving the competitive edge of existing companies.

Catalyst Program

- o Encourages the commercialization of clean energy technologies developed in the Commonwealth
- Awarded 19 grants used to demonstrate the feasibility of technologies in specific industry applications in order to obtain increased industry and investor interest
- o Prior Catalyst grant awardees have raised over \$35 million in follow-on funding.

Platform Program

 Enabled 22 entrepreneurs to present business plans to "dream team" of successful investors and consultants who provide valuable feedback

Technology Events

 Highlighted new and enhanced technologies to potential collaborators and investors. Event themes included Early Stage Life Sciences (20 companies represented), Mass Life Sciences Innovation Day life sciences (22 companies represented), and Global Clean Tech Meet Up (37 companies represented)

MassVentures stimulates the innovation economy by providing capital and one-on-one mentoring to high-growth potential technology companies.

- START Program Awarded \$2 million in Small Business Innovation Research (SBIR) related funding to help 17 growing companies commercialize technology developed under the SBIR contracts
- Invested \$1.8 million in seven Massachusetts companies, including 1 new investment, leveraged by over \$67 million of private capital
- Mentored 50 companies and built relationships with new co-investors, venture capital firms and the entrepreneur community; reviewed 256 business plans; met with 171 businesses.

Next Steps

The Office of Performance Management and Oversight has served to improve efficiency and delivery of economic development efforts throughout the state. The increased collaboration and alignment with the economic development plan, Choosing to Compete in the 21st Century, has been an integral part of our progress. We recommend the following to improve our effectiveness, accountability, and transparency of economic development efforts across the state.

- **Communication** Continued ongoing communication with the agencies on progress against plan progress will be posted on economic development plan website and communicated to key stakeholders.
- Information Management System Recommend incorporating measurable data into the Commonwealth's information management system (under development) to enable periodic, high level snapshots and reports of key economic data across the Secretariat and agencies.
- Fiscal Year 2016 Agency Plans Typically, we receive the first drafts of the fiscal year plans two months prior to the beginning of the new fiscal year. All plans include specific goals, performance measurements and demonstrate alignment with the Commonwealths economic development plan & policy. We recommend working with the new administration to determine the scope, timing, and content of FY16 plans.
- **Fiscal Year 2015 Annual Reports** Reports are typically received mid fall for filing and posting by calendar year end. We recommend working with the new administration to confirm timing and process to meat the calendar year end deadline. Fiscal year 2015 plans for the 19 economic development organizations are posted on the OPMO website.
- **Best Practices Workshops** We recommend a midyear workshop to provide status updates and collaborative successes to build on.
